MoU establishes the following:

Objectives

Duration

Undertaking

Both the parties undertake to work very closely and cooperate in the implementation of this MoU.

Effective Dates And Amendments

- a) This MoU shall take effect upon signing by both Parties and shall remain in effect for a period of three (3) years from the date of signing the agreement unless terminated. Neither party may assign or transfer all or any portion of this MoU without the prior written consent of the other party.
- b) The MoU may be renewed at the end of this period by mutual written agreement by both Parties.
- c) The provisions of this MoU may only be amended or waived by mutual agreement by both Parties.
- d) Any Party may terminate this MoU and any related agreement for any reason by giving thirty (30) days prior written notice to the other Party.

Relationship

Nothing in this MoU shall be construed to make Party, a partner, an agent or legal representative of the other for any purpose.
