### AGREEMENT

**This agreement is made at Varanasi on the ..... between the "Vasant Kanya Mahavidyalaya Kamachha, Varanasi 221010 (Run by The Indian Section, the Theosophical Society) Admitted to the Privileges of Banaras Hindu University." acting through The Principal, Vasant Kanya Mahavidyalaya Varanasi. (hereinafter called 'First Party' which expression shall, unless repugnant to the context or meaning thereof be deemed to mean and include its successors, legal representatives and assigns) of the First Part.**

And

**ASG HOSPITAL PVT. LTD., Located to Ground Floor Corporate Plaza, Gopal Vihar Colony Near AGR Automobile, Mahmoorganj, Varanasi having its Registered Office at Plot No.1 Shyam Nagar, Pal Link Road, Jodhpur, Rajasthan (herein after called the 'Second Party' which expression unless repugnant to the context shall mean and include its successors-in-interest assigns etc.) of the Second Part.**

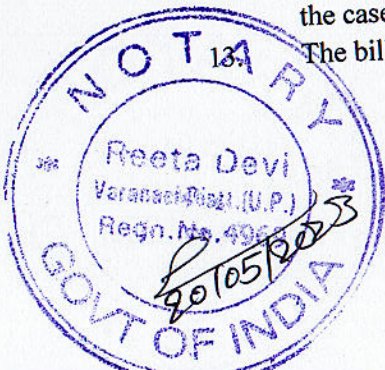


#### Statutory Alert:

Now this Agreement witness as under:-

1. That the Second Party shall accept the cases of employees of the First Party and their dependents for providing OPD consultation and Indoor treatment including pathological and other investigations.
2. That the Second Party shall provide **CASH LESS TREATMENT** to the employees of the First Party and their dependents for providing OPD consultation and Indoor treatment including pathological, other investigations and pharmacy facilities.
3. As the case brought into the notice by the Second Party that they are unable to provide consultancy of few prominent doctors on CGHS (Allahabad) rate as mentioned in the list (enclosed), the First Party is only liable to pay the CGHS (Allahabad) rates and the Second Party may receive the balance payment from the employees of the First Party.
4. While providing OPD consultation a patient is to be entertained only if he/she produces a copy of the cover page of the Health Diary/card of the patient/dependent issued by the First Party. The Health Diary/card number shall be mentioned in the OPD registration form of the Second Party.
5. The Second Party shall provide medical treatment facilities for charges on existing Central Government Health Scheme (CGHS Allahabad) rates as per Allahabad Circle in force.
6. The agreement shall be initially for a period of **two years** and may further be renewed for a period of two years, However, if the rate of the CGHS is revised, it will be automatically applicable.
7. Either Party may terminate the agreement by giving one month prior notice on writing.
8. Bed Charges/Room Rent/Operation Theatre Charges etc. shall be charged by the Hospital as per existing CGHS rates.
9. The First Party may authorize an official to visit the premises of the Second Party for verification of patient details and the Second Party shall facilitate in the verification.
10. The Second Party shall be solely liable for any of claims from the employees of the First Party against negligence or deficiency in service provided by the Second Party.
11. Any disputes of whatsoever nature between the parties arising during the terms of agreement thereafter shall be referred to the sole arbitrator appointed by the Principal, **"Vasant Kanya Mahavidyalaya Kamachha, Varanasi-221010 (Run by The Indian Section, The Theosophical Society) Admitted to the Privileges of Banaras Hindu University."** The award of the arbitrator shall be final, conclusive and binding on both the parties.
12. In case of any dispute the Civil Court, Varanasi shall have the jurisdiction to dispose off the case.  
The bills raised by the Second Party will be paid within 30 days.

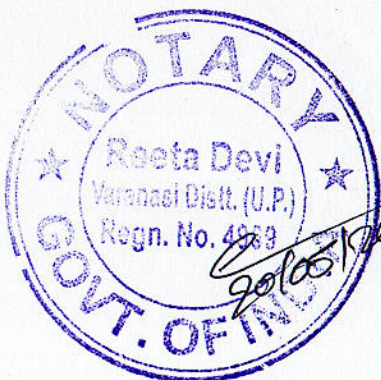
