In that case, any Party may terminate this MOU and any related agreement for any reason by giving thirty (30) days prior written notice to the other Party.
- b) The provisions of this MOU may only be amended or waived by mutual agreement by both Parties.

#### 4. RELATIONSHIP

Nothing in this MOU shall be constructed to make Party, a partner, an agent or legal representative of the other for any purpose.
