MEMORANDUM OF UNDERSTANDING (MoU) BETWEEN G.V. MEDITECH Pvt. Ltd. & VASANT KANYA MAHAVIDYALAYA

This Agreement is made at Varanasi this 15th May 2024 day between **G. V. Meditech Pvt. Ltd.** a licensed company registered under the Companies Act, 1956 and having its Office at B- 38/46- H, Raman Niwas, Mahmoorganj, Varanasi- 221010(India), hereinafter referred to as "**GVMPL**" and **VASANT KANYA MAHAVIDYALAYA, Kamachha, Varanasi- 221010 (Run by Besant Education Fellowship), (Admitted to the privileges of Banaras Hindu University) (India)**, hereinafter referred to as "**VKM**" of the Other Part.

- A. **GVMPL** is a licensed company and is going to be engaged in providing services to the employees of **VKM** and their dependents.
- B. The services of **GVMPL** include facilitating the provision of **cashless** treatment in hospitals for hospitalization, consultation, diagnostic and health check-ups to the employees of the **VKM** and their dependents.
- C. **GVMPL** will through the hospitals provide medical services (**Cashless**) to the employees of **VKM** and their dependents.
- D. The **GVMPL** has informed **VKM** that it is duly authorized/approved to operate a number of Hospitals under the name and style of **Surya Super Speciality Hospital** and **Surya Heart Center**.
- E. The **GVMPL** has approached **VKM** for empanelment so that they can provide medical/health services to the employees and their dependents of **VKM** for their health portfolios.
- F. The Company **G.V. Meditech Pvt. Ltd.** having two divisions in Varanasi is well equipped to provide the services being on offer and will be provided to **VKM** at places, the details of which are as follows :
 - a. **Surya Super Speciality Hospital** -- Dayal Enclave, Mahmoorganj, Varanasi
 - b. **Surya Heart Center** -- Raman Niwas, Mahmoorganj, Varanasi

1. **Employees on Ad Hoc with their dependents will be served on CGHS Rates in CASH Basis (Letter should be provided as on Ad Hoc at the time of registration).**

2. Employees those who are **RETIRED** will be served with **SPOUSE** on **CGHS Rates in CASH Basis (Any identity should be provided as RETIRED with Spouse name at the time of registration).**
3. Students of **VKM** along with their parents will be served on **CGHS Rates in CASH Basis (ID along with Father/Mother name should be provided at the time of registration).**

NOW THEREFORE THIS AGREEMENT WITNESSETH AS UNDER :

1. Identification

For the purpose of identification of its clients, **VKM** shall provide each beneficiary with a Identity Card with photographs. The beneficiary will present this card at the time of admission for the purpose of Identification and Medical Treatment.

2. Procedure for Admission

Request for hospitalization shall be made by the beneficiary as per the admission format provided to **VKM** along with bill submission form, Discharge Summary etc.

3. Procedure after Discharge

After a beneficiary is discharged from the hospital, the **GVMPL** will submit the documents to **VKM** in Original, within 10 days of the DOD (Date Of Discharge).

4. Procedure Of Charges

The **GVMPL** agrees to serve **VKM** on **CGHS Rates for OPD treatment, IPD treatment and Investigations.** It will be modified only when CGHS rates are revised. For Medicines, there will be a discount of **5% on MRP.** Consumables & Implants will have to be paid as per actual.

5. Applicable Law and Jurisdiction

- a. This Agreement and any matters relating to this Agreement shall be governed by and construed in accordance with the laws of India.
- b. The parties submit and agree to the exclusive jurisdiction of the Courts in Varanasi for redressal of any dispute.

Payment Terms & Condition

VKM agrees to pay all completed and approved claim bills as per **CGHS** rates within 30 days, subject to availability of funds.



6. Duration/Period of the Agreement


This Agreement shall be valid for a period of two years from the date of execution of the agreement unless terminated by either Party by giving a months' notice from either side. This Agreement may be renewed on mutually agreed terms and conditions between the Parties hereto, after expiry of two years.
